Qualifications/Guidelines for entry:

Open to girls age 12 and under.

How to Enter:

- 1) Completed and signed entry form.
- 2) One professional, high-resolution 8x10 or 5x7 photo, which will serve as the opening spread of the article if selected winner.
- 3) Five candid photos.
- 4) A 150-word description about why the applicant should be selected as the winner.
- 5) All entries must be postmarked no later than April 1, 2010. Proof of mailing does not constitute proof of delivery.
- 6) All entries must include a \$25.00 non-refundable entry fee made payable to Serendipity Publishing.
- 7) If you would like your photos back at the end of the contest, please also include a self-addressed stamped photo envelope.

Incomplete entries will be ineligible for judging and the entry fee will be forfeited. Lost, late, illegible, and postage-due entries are not eligible. Limited to one entry per person. Need not be a subscriber to *fourpoints* Magazine to enter.
